#### 2. HAZARDS IDENTIFICATION

Main hazards: Flammable. Repeated exposure may cause skin dryness or cracking.

Other hazards: The hazards for this product are mainly associated with the solvent, which is low aromatic white

spirit. However, the product as supplied has a viscosity in excess of 7 centipoise at 40 deg C, and hence does not carry the R65 risk phrase. There may also be a residual level of free

anhydride, this is at too low a level to be accurately determined.

### 4. FIRST AID MEASURES (SYMPTOMS)

Inhalation: Remove casualty from exposure ensuring one's own safety whilst doing so. Consult a doctor.
